**RESOLUTION RECOMMENDING SMALL VALUE PROCUREMENT AS
MODE OF PROCUREMENT FOR THE ENGAGEMENT OF
CONSULTANCY SERVICE/CERTIFICATION BODY FOR ISO 9001:2015 QUALITY
MANAGEMENT SYSTEM (QMS) WITH SURVEILLANCE AUDITS**




