**RESOLUTION RECOMMENDING COMPETITIVE BIDDING AS  
MODE OF PROCUREMENT FOR THE ENGAGEMENT OF SECURITY SERVICES FOR NRO2  
BUILDINGS, FACILITIES AND PREMISES FOR THREE-YEARS**

**WHEREAS**, it is the task of the National Economic and Development Authority Regional Office 2 (NRO2) Procurement, Bids and Awards Committee (PBAC) to assist and ensure that NEDA Regional Office 2 abides by the standards set forth by R.A. 9184 otherwise known as *"The Government Procurement Reform Act"* (As Amended) and its Revised Implementing Rules and Regulations (IRR);

**WHEREAS**, the NRO2 PBAC has received Purchase Request No. 18-02-026 on February 15, 2018 for the procurement of Security Services for NRO2 buildings, facilities and premises for three years;

**WHEREAS**, NRO2 allocated fund of FOUR HUNDRED SIXTY FIVE THOUSAND PESOS (Php465,000.00) from the General Appropriations Act of CY 2018 as the Approved Budget for the Contract (ABC) for the period April 1, 2018 to December 31, 2018 of the first year of the three-year term of Security Service contract;

**NOW, THEREFORE**, we, the members of the NRO2 Procurement, Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**, to recommend Competitive Bidding as mode of procurement for the engagement of Security Services for the NRO2 buildings, facilities and premises for three years.

**RESOLVED FURTHER** that a copy of this Resolution be forwarded to the Finance and Administrative Division with a specific instruction to prepare all supporting documents for posting to PhilGEPS, to include, among others, the Public Bidding Document (PDC) and Invitation to Bid (ITB).
