INVITATION TO BID FOR THE PROVISION OF SECURITY SERVICES TO NEDA REGIONAL OFFICE 2 BUILDINGS, FACILITIES AND PREMISES FOR THREE YEARS

1. The National Economic and Development Authority Regional Office No. 2, through the General Appropriations Act of CY 2018 intends to apply the sum of FOUR HUNDRED SIXTY FIVE THOUSAND PESOS ONLY (PhP465,000.00) being the Approved Budget for the Contract (ABC) for the PERIOD April 1, 2018 to December 31, 2018 of the first year term of the three-year Security Services contract. Bids received in excess of the ABC shall automatically be rejected at bid opening.
2. The National Economic and Development Authority Regional Office No. 2 now invites bids for the provision of Security Services for three (3) years where the contract is subject to annual review and performance evaluation. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
5. Interested bidders may obtain further information from the Finance and Administrative Division of National Economic and Development Authority Regional Office No. 2 and inspect the Bidding Documents at the address given below during Mondays to Fridays at 8:00a.m. to 4:00 p.m.
6. A complete set of Bidding Documents may be acquired by interested Bidders on **February 26, 2018** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos (PhP500.00).*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

7. The National Economic and Development Authority Regional Office No. 2 will hold a **Pre-Bid Conference on March 6, 2018; 10:00 in the morning** at NEDA/RDC2 Building, Regional Government Center, Carig Sur, Tuguegarao City, which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat at the address below on or before **10:00 in the morning of March 20, 2018**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clauses**.

Bid opening shall be on **March 20, 2018 at 10:30 in the morning** at the Calaba Room of NEDA/RDC2 Building, Regional Government Center, Carig Sur, Tuguegarao City. Bids will be opened in the presence of the bidders or bidders' authorized representatives who choose to attend at the address below. Late bids shall not be accepted.

9. The National Economic and Development Authority Regional Office No. 2 reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


